

THE £1 CHALLENGE COMPETITION TERMS AND CONDITIONS

1. These terms and conditions together with any specific rules set out in Competition Notices (as defined below) are the Competition Rules ("Rules") and apply to competition on the The £1 Challenge "Site" (www.1poundchallenge.co.uk) ("Competition"), unless otherwise expressly stated. By entering a Competition, entrants agree to be bound by these Rules.

2. The Competition is organised by The £1 Challenge ("The £1 Challenge").

3. Rules specific to this Competition is displayed in a notice on the page for such Competition ("Competition Notice") and are incorporated into the Rules. In the event of discrepancy between these terms and conditions and the Competition Notice, the Competition Notice shall prevail.

4. The £1 Challenge reserves the right to cancel or amend the Competition or the Rules without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside The £1 Challenge reasonable control. Any changes will be posted either within these terms and conditions or the Competition Notice.

5. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to a Competition, the decision of The £1 Challenge shall be final and no correspondence or discussion shall be entered into. Qualifying Entrants

6. Team members of The £1 Challenge or any company involved in the Competition or any advertising agency or web company connected with The £1 Challenge or any such person's subsidiary or associated companies, agents or members of their families or households, are not eligible to enter the Competition.

7. By entering the Competition, you hereby warrant that all information submitted by you is true, current and complete. The £1 Challenge reserves the right to verify the eligibility of all entrants.

8. The address you provide with your competition entry ("Entry") will be used to send any prizes so please make sure this is correct. You are not entitled to enter the Competition if you are resident in a country or jurisdiction (outside the United Kingdom or Republic of Ireland) where the Competition may breach any law or regulation. Where this applies, The £1 Challenge invitation to enter the Competition in such country and/or jurisdiction is withdrawn.

9. This Competition is only open to a certain age group (18 and over), and is set out Competition Notice and The £1 Challenge assumes that by entering the Competition (and you warrant that) you are the appropriate age to enter the Competition.

10. The £1 Challenge reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.

11. In the event that any entrant is disqualified from the Competition, The £1 Challenge in its sole discretion may decide whether a replacement should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these Rules.

Competition Entries

12. You may only enter the Competition once however where a winner has been selected and The £1 Challenge discovers or has reasonable grounds to believe the winner has used any software or automated process either to answer questions or to make bulk entries, the £1 Challenge may select an alternative winner. Any further winner will be selected on the same criteria as the original winner and will be subject to these Rules.

13. Competition entries must be made in the manner and by the closing date and time specified on the Competition Notice. Failure to do so will disqualify the entry.

14. There is no purchase requirement to enter a Competition and there is no charge to register for use of the website.

Prizes

15. Prize winners will be chosen at random, from all qualifying Entries within 28 days of the closing date specified in the Competition Notice.

16. Prize winners will be notified in the manner and within the time specified on the Competition Notice. Return of any prize notification as undeliverable or failure to reply may result in disqualification and selection of an alternate winner. Prizes are awarded in 1st, 2nd and 3rd places and only one prize per winner will be awarded. Competition winner(s)' names may be published on the website and blog.

17. Prizes are non-transferable and there is no cash alternative. The £1 Challenge reserves the right to substitute prizes of equal or greater value at any time.

18. Prizes are awarded at The £1 Challenge discretion and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.

19. The £1 Challenge cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant entering the Competition or as a result of accepting any prize. The £1 Challenge is not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination of these, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation or downloading any materials in the Competition. Nothing shall exclude The £1 Challenge liability for death or personal injury as a result of its negligence.
